The remaining balance (NON REFUNDABLE)is to be paid on the day of the scheduled trial run OR one month prior to the wedding day. . If no trial run is selected, final payment is required one month prior to the Wedding day . Payment accepted: Credit (3% fee assessed ) or cash or cashiers check .

\***Assistant fee.** If your event requires additional stylists due to a large party or a time restraint there will be an additional \$75/hour or \$85/ per head fee. The assistant will be of my choosing unless otherwise noted.

\***PARKING.** Parking reimbursement is appreciated.

**HOTEL:** If hotel accommodations are required because of an early start time or a location greater than two hours drive time, the client will compensate for the hotel charges.

### **INSTRUCTIONS:**

\* I provide a hand mirror, power strips, products and supplies, and music (if needed).

\* Pictures of the desired styles are appreciated but please understand that hair type, condition, and color can result in variation of styles. Please come with a 100% dried hair unless otherwise noted.

\* Avoid flat ironing your hair that day because it can make curling the hair difficult.

- \* A zip up or button up top is recommended to not disturb you and your beautiful wedding parties formal style.
- \* Please arrive to your appointment on time. If any of the bridal party is late it could compromise the completed look of the Bridal party.
- \* Please share this info sheet with the entire wedding party . It will be smooth sailing !
- \* If using a make-up artist, please coordinate times and looks directly with them . If you need a MUA let me know. I work with the Twin Cities best artists.
- \* Please feel free to contact me ANYTIME regarding you event. I am professional yet playful. I am very excited to work with you for your event!
